Violation(s) / Comment(s) (Chapter 3717-1 OAC violations checked)

Cold food below 41°F. Hot water adequate. The following violations were noted:

(Critical) 06.4 Physical Facilities: Maintenance and Operation

(K) Controlling pests.

Observed rodent droppings on countertops, under microwave, along floor and walls, on storage shelves, and in storage room. Operator said they do not have pest control. Clean facility of droppings today and contact pest control company to treat facility for pests.

(Critical) 04.5 Equipment, Utensils, and Linens: Cleaning of Equipment and Utensils

(A) Equipment, food-contact surfaces, nonfood-contact surfaces, and utensils.

Food contact surfaces of microwave, pizza oven, and popcorn machine dirty with food residue. Clean food contact surfaces of cooking equipment daily. Inside of ice machine has an accumulation of mold. Clean routinely to prevent such accumulation. Correct today.

04.2 Equipment, Utensils, and Linens: Numbers and Capacities

(I) Sanitizing solutions - testing devices.

Could not locate test strips for sanitizer. Obtain and use to monitor concentration of sanitizers.

(Critical) 04.6 Equipment, Utensils, and Linens: Sanitizing of Equipment and Utensils

(A) Food-contact surfaces and utensils.

Could not locate sanitizer to use for sanitizing dishes in 3 compartment sink. Obtain and use to wash, rinse, and sanitize food contact surfaces. Correct today.

06.4 Physical Facilities: Maintenance and Operation

(B) Cleaning - frequency and restrictions.

Floors, storage room, restrooms, and hard to reach areas dirty to sight. Clean such areas daily to prevent accumulation of debris.

(N) Maintaining premises - unnecessary items and litter.

Observed many un-used items and equipment in concession. Store any un-used items in a separate location. Remove any un-used food equipment from concession to allow routine cleaning.

07.1 Poisonous or Toxic Materials: Operational Supplies and Applications

(A) Storage: separation.

Store all chemicals away from food or food prep areas to protect food from cross contamination.

Operation agreed to temporarily close food concession until cleaning is completed. Follow-up inspection will be conducted on 2/23/10.
